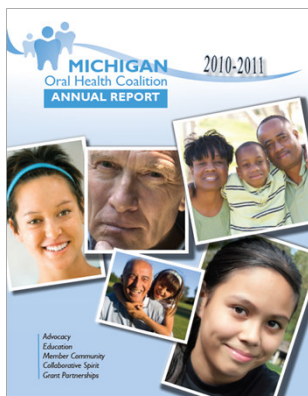

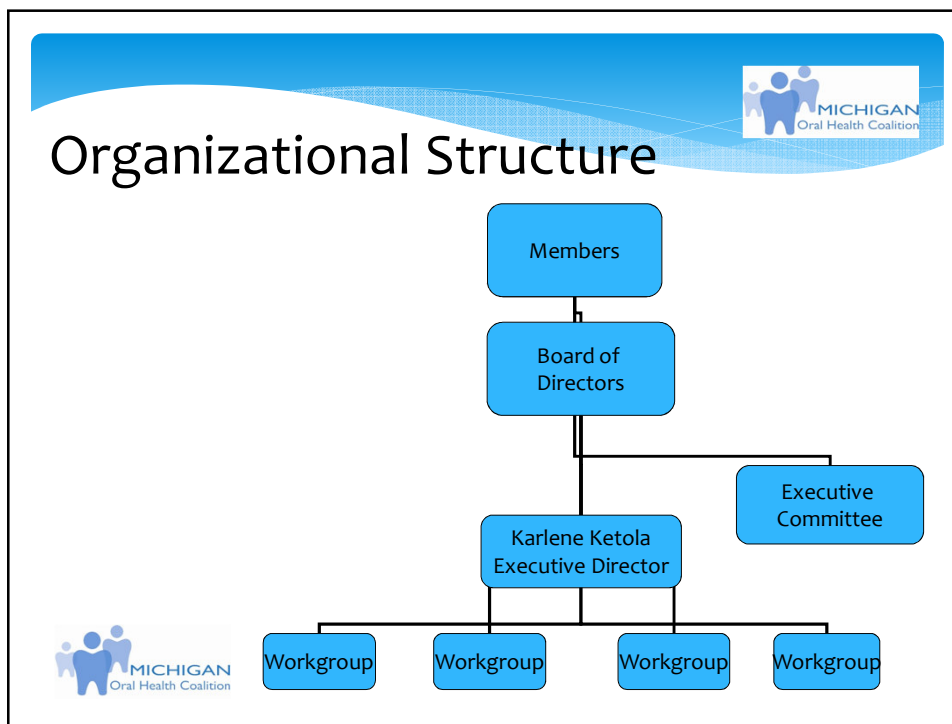

Coalition Structure



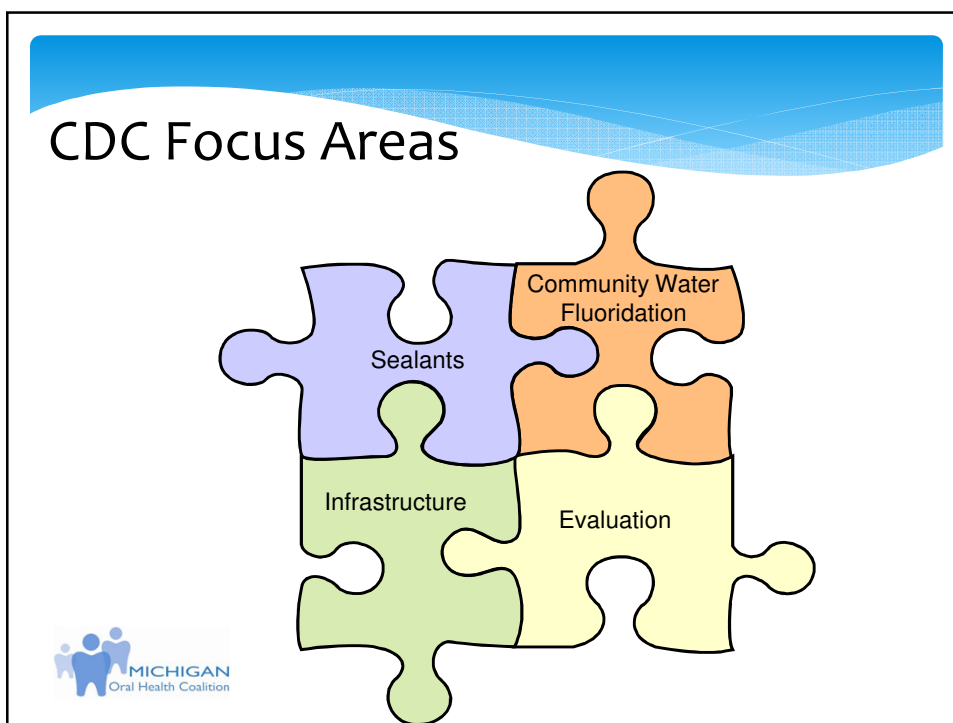
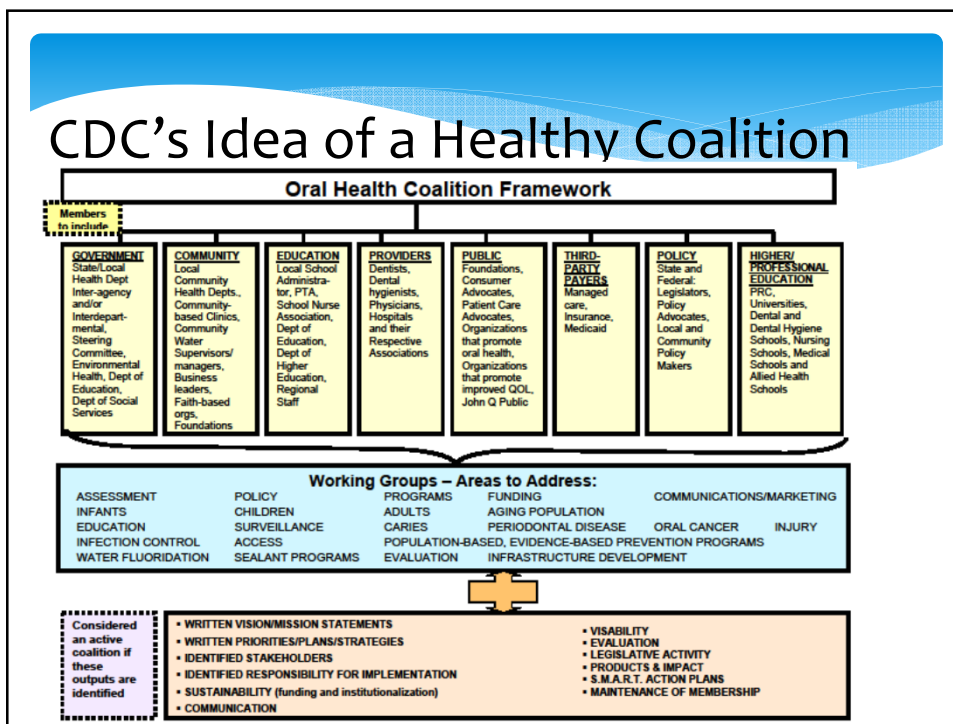
- Formed in response to 2003 elimination of adult dental
- 501(c)3 non-profit organization
- 501(h) election from the IRS
- Michigan is a CDC Cooperative Agreement Grantee
- Full-time Executive Director
- Annual Budget, \$130,000
- Administration agreement with the Michigan Primary Care Association for accounting, payroll and IT
- 10-member board; 125 Coalition members
- State Oral Health Director serves as ex-officio board member



CDC Cooperative Agreement Grant

- Centers for Disease Control and Prevention funds 19 states.
- Cooperative agreements range from \$234,408 to \$355,000 per year and are renewable for up to 5 years. Michigan is in its fourth year. Coalition received \$45,890 for FY 2010-11.
- Funding designed to improve basic state oral health services.

Coalition Legislative Priority 1

Medicaid Adult Dental

Call to Action: Maintain Medicaid adult dental. As lawmakers deliberate the FY 2012 state budget, we ask that Medicaid adult dental remain in the Michigan Department of Community Health budget. For every 34 cents Michigan spends on Medicaid, the state receives 66 cents in federal match.

Budget: \$5.4 General Fund; \$14.2 Federal Match



Coalition Legislative Priority 2 Healthy Kids Dental

Call to Action: Expand the Healthy Kids Dental program to every Michigan county ensuring all children receive the care they need for a healthy mouth, and a healthy body.

To expand HKD statewide, the budget would need to increase an estimated \$75 Million (approximately \$25.3 Million General Fund; \$49.3 million federal match).



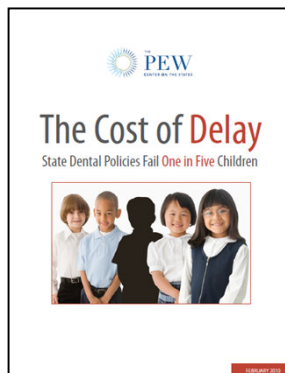
Coalition Legislative Priority 3 Prevention

- * Make legislators aware the Coalition's works to increase community water fluoridation and increase the number of children that have sealants on their teeth.
- * Share the State Oral Health Plan with your legislator.
- * Healthy People 2020 Goals:
 - Increase the proportion of children and adolescents who have received dental sealants on their molar teeth.
 - Increase the proportion of the U.S. population served by community water systems with optimally fluoridated water.



Pew Report

- Michigan received a “C”
- MI has less than 25% of high-risk schools with a sealant program in place
- MI does not have a mandatory dentist exam prior to sealant placement
- MI reimburses medical providers for preventative oral health care
- MI (40%) of standard median provider rates; Standard rate, 60.5%
- MI exceeds national average of utilization rates
