Diabetes: Oral Care What's in There? Webinar November is Diabetes Awareness Month

Periodontal (gum) disease has been called the sixth complication of diabetes (in addition to eye, kidney, nerve, foot, and cardiovascular complications) because so many people with diabetes have it. Having high blood glucose raises the risk of developing periodontal disease, and periodontal disease tends to raise blood glucose levels. So clearly, making an effort to brush, floss, and have regular dental checkups is important when you have diabetes. Join us Nov. 6 (from 10 to 11 a.m.) to familiarize yourself with the techniques to treat a patient with diabetes. Although brushing and flossing are important, there are other ways to achieve oral cleanliness using insightful advances in dental materials.

November is American Diabetes Month. With nearly 24 million Americans living with diabetes; and an additional 57 million Americans at risk-- providers must familiarize themselves with the systemic and oral aspects of the disease. Did you know tobacco use is the leading cause of preventable death in Michigan and a major risk factor in the development of oral cancer? In a ranking of preventive services for the U.S. population, the National Commission on Prevention Priorities rated smoking cessation services as one of the three most cost effective prevention services available. Oral health professionals have a wonderful opportunity to talk with their patients who use tobacco about their willingness to quit, and to educate them on the benefits of a healthier lifestyle without tobacco. Last fall, the Coalition teamed up with the Michigan Department of Community Health, Tobacco Section and Michigan Primary Care Association to offer a workshop on the relationship between tobacco and oral health. State News

FY 2010 Budget Battle Continues **Governor Signs Interim Budget**

Early this morning, Governor Jennifer Granholm signed a continuation budget which prevented a partial shutdown of state government. The legislation signed today will be in place until Oct. 31, 2009 or until the governor signs departmental appropriations bills, whichever comes first. While the governor has supported over \$1 billion in painful spending cuts to balance the budget, she has rejected Senate Republican cuts that eliminate college scholarships for over 50,000 Michigan students, slash funding for local police and fire services, and reduce funding critical to bringing new jobs to the state. The Coalition will continue to keep you updated on the FY 2010 budget.

MDCH Makes Its Move to CHAMPS **Coalition Hosts Webinar on November 16**

Last month, Medicaid made its official switch to the Community Health Automated Medicaid Processing System or "CHAMPS." CHAMPS Update, Sept. 30, 2009

The following notice was posted to the Medicaid website regarding some claims being denied in error.

"In accordance with the Executive Order 2009-22, the Michigan Department of Community Health (MDCH) eliminated certain covered service benefits for Medicaid beneficiaries age 21 and older, and implemented program/fee reductions effective for dates of service on and after July 1, 2009. Currently claims that are affected by this Executive Order are denying incorrectly in CHAMPS. After the issue is resolved, MDCH will recycle all of the affected claims so that services are properly adjudicated. Delta Dental "Call for Applications"

The Delta Dental Foundation is pleased to announce a "Call for Applications" for its 2009 Community Mini-Grant Program. A total of \$70,000 will be awarded to assist in addressing the oral health needs of children in Michigan, Ohio, and Indiana. Community-based oral health programs in the tri-state area are encouraged to apply for grants up to \$5,000 for programs designed to improve oral health. Special consideration will be given to those applicants whose programs focus on improving the oral health of low-income children, however, all grant submissions will be considered. To be considered for the 2009 program, the Delta Dental Foundation must receive completed contribution request applications no later than Oct. 16, 2009. Grant recipients will be notified by the end of the year.

The Michigan Department of Community Health (MDCH) Oral Health program is looking to promote community water fluoridation by offering to reimburse Michigan communities currently not fluoridating for fluoridation equipment purchases for the sole purpose to initiate community water fluoridation in their community. 2009 Kaiser Study on Medicaid Released

Spending, Coverage and Policy in the Midst of a Recession

According to a Kaiser Commission on Medicaid and the Uninsured study, the recession was the dominant driver of Medicaid spending and enrollment growth as well as changes in policy for state fiscal years 2009 and 2010. Rising unemployment, sharp declines in state revenues and higher demands for public programs including Medicaid left states with severe budget gaps. The impact of the temporary Medicaid fiscal relief provided through the American Recovery and Reinvestment Act (ARRA) proved to be critical in helping states balance their budgets and protect their Medicaid programs, but states still felt pressure to control Medicaid spending growth.
