Medicaid Adult Dental Reinstatement Continued Advocacy Efforts Needed

The House and Senate returned to Lansing this week from their spring recess. With a projected budget shortfall of \$1.6 billion, the Legislature's top priority is the FY 2011 budget. Last month, the Senate Appropriations Committee passed its version of the Department of Community Health budget, which includes adult dental. As the budget process moves ahead, the Coalition will continue its advocacy efforts. On April 19, members Cheryl Gildner, Ingham County Health Department and Dr. Jane Grover, Center for Family Health will testify at the final House Appropriations Subcommittee hearing on the DCH budget. On Monday, the Michigan Oral Health Coalition partnered with Oral Health Kansas and Virginia Oral Health Coalition for a webinar on the oral health provisions in health reform. Dr. Burton Edelstein, Columbia University professor and Children's Dental Health Project founder led discussion on the new programs and dollars which will be directed to Prevention, Workforce, Safety Net Providers, Infrastructure and Surveillance.

Dr. Edelstein also shared that with the crafting of the law, Congress sent a strong message to all Americans--"Oral health is integral to overall health in federal policymaking." The oral health provisions of the law are embedded throughout the text, in concert with similar physical health provisions. This is an important sign that oral health shouldn't be treated as a separate issue from overall health. Thank you to those oral health advocates who participated in the webinar.
