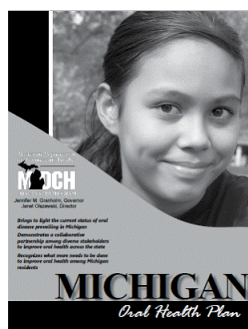

## Community Water Fluoridation Facts Did You Know?

...Grand Rapids was the first city in the nation to implement community water fluoridation. The year was 1945.

...The optimal level of fluoride to reduce dental decay is 1.0 ppm.

...Every \$1 invested in fluoridation saves \$38 in dental treatment costs.

Research shows water fluoridation reduces or eliminates disparities in preventing dental caries among different socioeconomic, racial and ethnic groups. Forsyth Township (Gwinn, Michigan) is the most recent community to review its continuation of water fluoridation. The Coalition along with its State Community Water Fluoridation Advisory Committee will continue its efforts to educate Forsyth Township council members and the public on the benefits of optimal fluoridation.

### "A United Voice for Oral Health"

#### **New Report Offers Solutions to Dental Care Access Issues**

Looking to help more Michigan residents get access to dental care, the 30-member Michigan Access to Oral Health Care Work Group issued a first-of-its-kind report outlining concrete strategies to help make sure people aren't forced to go without dental care.

"This brutal economy has heightened a long-standing problem - that when it comes to oral health care, many folks in Michigan simply can't get the care they need," said Norm Palm, DDS, MS, a Grand Rapids dentist who chaired the group, which was convened by the Michigan Dental Association. ### Bernero to Face Snyder for Governor

#### **Many New Faces in Michigan's**

After last week's primary, the race for governor, along with nearly all candidates for the Michigan House, Michigan Senate, and U.S. House seats, are set for the Nov. 2 general election. The Democrat and Republican parties will hold their state conventions Aug. 28, where they will officially nominate their candidates for attorney general and secretary of state. The gubernatorial candidates have been invited to speak and to bring their families. The Coalition will be exhibiting at the event to educate families on oral health.

### **CHAMPS Provides Transparency and Accountability MDCH Reports New System Has Exceeded Expectations**

Since going live with its major system components in September 2009, CHAMPS has exceeded expectations, handling millions of dollars a day in reimbursements for doctors, dentists, hospitals and nursing homes across the state. Michigan Department of Community Health (MDCH) reports the system has not missed a single payment cycle and is expected to process 56 million claims and encounters, totaling \$10 billion in payments on an annual basis for both fee-for-service and managed care recipients. ### **Developmental Disabilities Council RFPs Applications Due October 4**

The Michigan Developmental Disabilities Council is seeking RFPs for two projects: 1) A Working With Continuum of Care Bodies; and 2) Partners in Medicaid Policy. Eligible applicants include private non-profits, government agencies, and institutions of higher education that have, or can access, the skills and experience to carry out the projects. #### **About the Projects**

**RFP #2011.A:** Working With Continuum of Care Bodies will fund three (3) to five (5) local projects for three (3) years to support people with DD and their allies to be active in their local Continuum of Care Bodies, advocating and informing decision makers about the housing needs of people with developmental disabilities.

**RFP #2011.B:** Partners in Medicaid Policy will fund one state-level project to identify policy barriers to access and availability of comprehensive health care services for people with DD in Michigan; and develop and implement an advocacy plan for assuring that people with DD get the health care services they need.

### **U.S. House Passes State Aid Bill**

### Michigan to Receive \$698 Million for Medicaid, Education

On Tuesday, the U.S. House of Representatives approved by a vote of 247-161 a \$26 billion state aid bill (the Education Jobs and Medicaid Assistance Act, HR 1586) that includes a 6-month, \$16 billion extension of enhanced FMAP rates. The bill also includes funding to hire or rehire teachers. Michigan will receive \$698 million (\$380 million for the Medicaid fund and \$318 million for education). President Obama signed the bill within hours of the House vote. This will relieve some of the pressure to cut the state's FY 2011 budget deficit, which currently stands at \$560 million. There is still no concurrence among the administration and legislative leaders on how much of the new money to use as it only prolongs the need to deal with the deficit. However, it may make the possibility of a budget agreement easier and earlier. **Source:** MPCA e-update, August 13, 2010
